THE CITY'S BIG SERVICE ROLL-OUT

The City is making a big push to help all businesses comply with State recycling and organics recycling requirements before enforcement penalties go into effect on January 1, 2024. Businesses that have not been identified as compliant through either service subscription, approval of a City issued exemption, or registration and reporting as a self-hauler, will be provided with a WM recycling and/or organics service bin.

Recycling and organic recycling are mandated by the state because of their many social benefits. Both types of recycling reduce greenhouse gas emissions and return resources, that would otherwise be landfilled, back into something useful. All recycling extends the useful life of landfills.

You can help the City, and the environment, by being a proactive recycler. If your business does not already have mixed recycling and/or organics services, call the City today at (916) 617-4590. We can help you determine if you are eligible for an exemption to the service requirements. If service is required, we can help you select the appropriate service level and provide you with resources such as indoor bins and posters to help you successfully sort your waste. There is no additional cost to add mixed recycling services when you are a new or existing WM front-load or cart trash customer, and by subscribing to recycling services, you may save money by diverting waste and downsizing your trash services. There is an additional service fee for adding organics recycling services. Billing for the entry level organics services provided by WM start at approximately \$30 a month for a small 35-gallon residential type cart.



Please note, mixed recycling and organics recycling services are open market in West Sacramento, so all businesses may switch to another permitted waste service provider for these services. Businesses may apply for an exemption to the service requirements and/or register as a self-hauler by visiting https://connect.re-trac.com/registration/cityofwestsacramento.
